Serving on the ACC board of directors has been a highlight of my career. Not only have I had the opportunity to work alongside other extremely talented board members and ACC leadership, but I have grown and learned from so many within the global in-house community as an ACC member. Stepping into the role of board chair of this amazing association has been an immense honor and a very rewarding and fulfilling experience. As the world is still dealing with the implications of a global pandemic, I am proud of the work ACC has done and continues to do, to help our members lead and support their organizations and communities. In fact, in 2022 we celebrate [40 years](#) of doing just that!

Not only have I had the opportunity to work alongside other extremely talented board members and ACC leadership, but I have grown and learned from so many within the global in-house community as an ACC member.

A look back ... and forward

Some of that vital work included continuing ACC's commitment to diversity and inclusion within our profession. We launched the ACC Foundation's [Diversity, Equity, and Inclusion \(DEI\) Maturity Model](#) (MM) last year, and this year expanded its reach and potential through a partnership with Ethisphere. I applaud Team ACC on the many events, roundtables, and articles focused on this initiative that have helped law departments and organizations take a deeper look at their DEI functions and

procedures. Stay tuned for more to come on this exciting model, including an innovative DEI MM Benchmarking Assessment Tool, which will allow legal teams to further access and advance their efforts in this area.

In addition, we released important research like our annual [Chief Legal Officers Survey](#), which offered insights from over 850 CLOs representing 20 industries and 38 countries. The report found that CLOs play a critical role in a company's leadership and as such, have increasing responsibilities in business functions like compliance (80 percent), ethics and privacy, and, of course, risk. Further, the report found that nearly a quarter of those surveyed have responsibilities in their organizations environmental, social, and governance (ESG) efforts. This is an area of significance for me, and I know many of you as well. In fact, I recently published an article for the *China Business Journal*, "[Steering the ESG Shift.](#)" I encourage you to check it out – I'd love to hear [your thoughts](#) on how in-house counsel can lead and support our teams in this important area.

Other notable research included the [Trends in Legal Transformation and Technology Report](#) (in partnership with DISCO), which captures insights from 278 law department leaders and legal operations professionals on how they've engaged transformation within their departments. I have highlighted just a small sample of ACC Research here and encourage you to learn more at [ACC.Com/survey-reports](#). In fact, if you are a CLO and would like to contribute to the conversation by [participating in the 2023 Chief Legal Officer Survey](#), you can do so until Oct. 28; the survey will be published in January!

This year also saw some of us tentatively coming back together again with in-person programming. [ACC Europe held its annual conference](#) in Madrid in May, the [Executive Leadership Institute](#) was held in July in Chicago, and the [Global GC Summit](#) was back in action in Zurich in June — the same month that ACC Foundation hosted its hybrid [Global Women in Law & Leadership](#) program. Again, I can't highlight all the innovative programming that happened this year, but you can peruse coming events on the [Conferences & Professional Development](#) page.
