## Building a strong AI governance structure

AI governance refers to the systems and processes put in place to ensure that AI technologies are developed and deployed in a manner that is legally compliant, ethically sound, and aligned with organizational goals. These AI technologies can mean:

- The artificial intelligence technique, algorithm, model, or system themselves, such as data-based prediction models for weather forecasting,
- The enhancement of existing products (such as added thermostat functionality to predict and adjust to an expected cold front), and the development of new products (such as developing a wearable with integration of the expected weather and a person's own temperature).

For product lawyers, establishing a strong AI governance framework is useful to managing the complexities of AI while ensuring accountability and transparency. This involves creating policies that address the responsible use of AI's output, and the fair treatment of individuals impacted by AI solutions. It requires a robust review of existing and needed policies on data collection, processing, management, and security. It may also include developing an efficient process to submit required reports, conduct audits, and liaise with government regulators. Through the Product Counsel Framework, product lawyers can systematically integrate these considerations into a comprehensive governance structure, ensuring that AI solutions are developed with clear guidelines for responsible and compliant use from the outset.

- A product lawyer can analyze and recommend a strategy to develop and/or deploy AI responsibly within an organization. This strategy should be developed hand in hand with stakeholders in business (Does it offer a sensible ROI?),
- Technology (Do we have the infrastructure to support this?), and
- Compliance (Can a policy/program be operationalized and managed?).

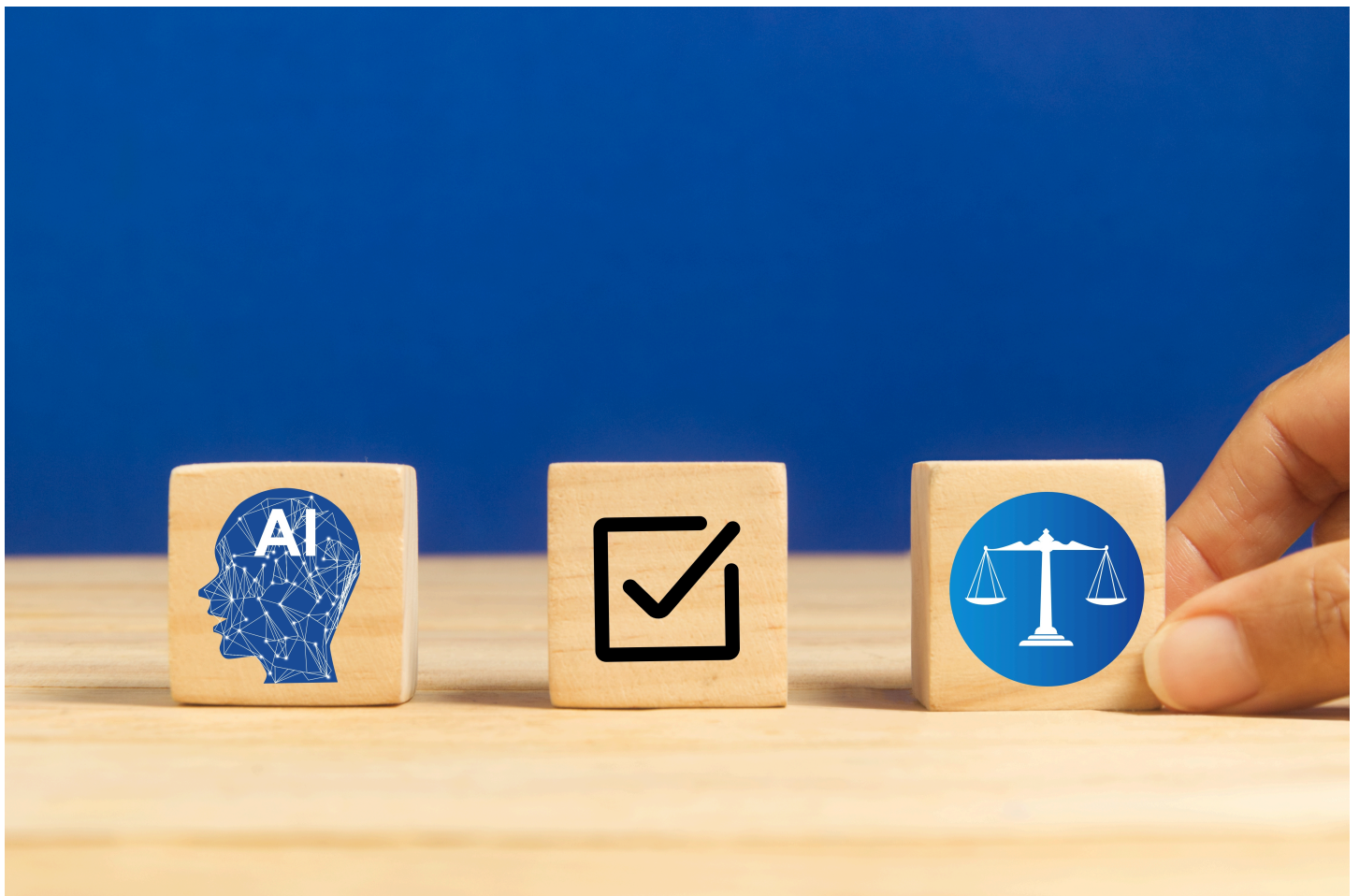

innovation, fostering trust and maintaining regulatory compliance in an increasingly AI-focused world.

## Managing risk and accountability in AI systems

The Product Counsel Framework supports product lawyers in setting up these oversight mechanisms, ensuring long-term accountability and the responsible use of AI technology.

## **Aligning AI with business and regulatory goals**
